

## 17 Arrested in Wilkesboros Drug Sweep

A joint drug investigation of the Wilkesboro and North Wilkesboro Police Department's Narcotics Units has led to the arrests of 17 people. The investigation has mainly focused on the sale of prescription drugs, but included the sale of methamphetamine, marijuana and cocaine. Nearly all the charges were the result of undercover operations conducted in both towns. The 17 people charged face a total of 68 charges, and police say all the suspects have been arrested and served with their warrants. Anthony Gwyn Hailey, 47, of East Street Wilkesboro has been charged with possession with the Intent to sell and deliver schedule VI controlled substance (marijuana), sell and deliver schedule VI controlled substance, manufacture of a schedule VI controlled substance and possession of drug paraphernalia.

Freddie Bishop Mitchell, 18, of W. Highway 268 Ferguson has been charged with possession with Intent to sell and deliver schedule II controlled substance (oxycodone) and sell and deliver of a schedule II controlled substance.

Jesse Aaron Childers, 26, of Lawson Childers Road Taylorsville has been charged with felony possession of schedule II controlled substance (oxycodone) and 2 counts of larceny by employee.

Dwight Eugene Baldwin, 33, of Rock Creek Church Road North Wilkesboro has been charged with 2 counts of possession with the intent to sell and deliver schedule II controlled substance (oxycodone), 2 counts of sale and deliver of schedule II controlled substance and 1 count of conspiracy to sell prescription medication.

Adrienne Louise Wilcox, 35, of Airport Road North Wilkesboro has been charged with 1 count of possession with the intent to sell and deliver a schedule II controlled substance (opana) and 1 count of conspiracy to sell prescription medication.

Brandi Nicole Lunsford, 29, of White Oaks Drive Ronda has been charged with 6 counts of obtaining prescription medication by fraud, 6 counts of obtaining by false pretense (prescription medication) and 1 count of obtaining a controlled substance by fraud (hydrocodone).

Jacquelyn Callena Kaiser, 18, of Cartpath Road North Wilkesboro has been charged with possession with the intent to sell and deliver a schedule II controlled substance (opana) and sale and deliver schedule II controlled substance.

Whitney Marie Bates, 21, of Newport Lane North Wilkesboro has been charged with 2 counts of possession with the intent to sell and deliver a schedule II controlled substance (oxycodone) and 2 counts of sale and delivery of a schedule II controlled substance.

Jonathan Keith Robinson, 24, of Old Highway 60 Millers Creek has been charged with 1 count of possession with the intent to sell and deliver a counterfeit controlled substance, 1 count of sale and deliver a counterfeit controlled substance, possession with the intent to sell and deliver a schedule II controlled substance (cocaine) and sell and deliver a schedule II controlled substance.

Jennifer Ann Coble, 31, of Gala Drive, North Wilkesboro has been charged with DWLR, 3 counts of possession with the intent to sell and deliver a schedule II controlled substance and 3 counts of sell and deliver a schedule II controlled substance.

Jamey Alan Combs, 42, of Bethany Ford Road, Roaring River has been charged with 3 counts of possession with the intent to sell and deliver a schedule II controlled substance (oxycodone) and 3 counts of sell and deliver a schedule II controlled substance.
